## Identity (To Be Signed at the Institution)

The student must appear in person at Skagit Valley College to verify his or her identity by presenting an unexpired valid government -issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student's ID.

(a) A copy of the **unexpired valid government-issued photo identification (ID)** that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to, a driver's license, other state-issued ID, or passport.

## Identity (To Be Signed in the Presence of a Notary)

If the student is unable to appear in person at Skagit Valley College to verify his or her identity, the student must provide to the institution:

- (a) A copy of the **unexpired valid government-issued photo identification (ID)** that is acknowledged in the notary statement on the next page, or that is presented to a notary, such as, but not limited to, a driver's license, other state-issued ID, or passport; and
- (b) When a notary public is used, ID and Statement with original "wet" (handwritten) signature must be either: 1) Hand delivered to the college, or 2) Mailed using U.S. Postal Mail, or commercial courier (such as UPS, FedEx, etc.). Cannot be faxed, emailed, texted, or uploaded to the college. No exceptions.
