

## 2025-2026 VERIFICATION OF U.S. CITIZENSHIP/ELIGIBLE NON-CITIZEN STATUS

Your FAFSA® (Free Application for Federal Student Aid) requires additional information. The U.S. Department of Education could not confirm your status as a U.S. citizen or eligible non-citizen. **You may provide proof of your eligible citizenship or immigration status in one of two options:**

**Option 1:** Come to campus in-person and present your *original* documents to the Financial Aid Office for validation. Complete page 2 of this document.

**Option 2:** Submit page 3-4 of this document via United States Postal Services, email (YOU MUST USE YOUR STUDENT EMAIL), or fax. IF YOU CHOOSE TO SUBMIT THESE DOCUMENTS REMOTELY VIA ONE OF THESE SERVICES YOU MUST:

- Present original documents to a Notary Public Official
- You and notary must complete page 3-4
- Mail, email, or fax page 3-4 to SVC Financial Aid Office **along with copies of the document(s) seen by notary**. Please note that all copies must be clear, legible, and nothing can be cut off or missing. Color copies are preferred.

### Required Documents

Check the status that applies to you and submit documents via option 1 or 2. Below are the most commonly received documents. If you aren't sure which document you should submit **PLEASE TALK TO US**. We are here to help you navigate this process.

☐ **I am a U.S. Citizen.** Submit **ONE** of the documents below.

- U.S. Birth Certificate
- U.S. Passport (MUST BE SIGNED)
- U.S. Passport Card
- Certificate of Naturalization/Citizenship (MUST BE SIGNED)

☐ **I am an eligible non-citizen.** Submit **ONE** of the documents below.

- U.S. Permanent Resident Card/Resident Alien Card
- Arrival/Departure Record (I-94) from USCIS showing any one of the following designations:
  - Refugee
  - Asylum Granted
  - Indefinite Parole and/or Humanitarian Parole/Cuban/Haitian Entrant
- T-visa issued to student or T-1 visa issued to student's parent.

### DACA and Eligibility for Aid

Undocumented students, including Deferred Action for Childhood Arrivals (DACA) recipients, are not eligible for federal student aid, but, may still be eligible for other types of student financial aid (such as state aid, school aid, or private scholarships). [The Washington Application for State Financial Aid \(WASFA\)](#) is for people who don't file a FAFSA®. **A person should complete the WASFA if they are undocumented or do not qualify for federal financial aid because of their immigration status.** The WASFA can also be used in limited circumstances by other [select applicants](#) who cannot or choose not to file a FAFSA.

## OPTION 1: PRESENT DOCUMENTS TO FINANCIAL AID OFFICE IN PERSON

(To be signed at Skagit Valley College)

The student must appear in person at Skagit Valley College to provide proof of U.S. citizenship or eligible non-citizenship status directly to a school official in the Financial Aid Office.
